### FROM THE DESK OF THE EDITOR



The picture on the left shows a villager in Pattipola, Sri Lanka, carrying a heavy burden of firewood back to his home. So, what has this got to do with the Eighty Club, did you ask? Nothing at all. However, I could not help but compare this heavy load with the weight of the cost of living that the poor in Sri Lanka have to bear especially our welfare beneficiaries.

Recently, there was some relief for fifty-one of our WBs. Entirely due to the ongoing generosity of all of our members, the Treasurer reported that we had some extra funds to distribute. So, it was decided to pay fifty-one of our welfare beneficiaries a sum of Rs.14,000 each as a special one-off bonus payment. We decided that a

substantial payment to even some of our beneficiaries would enable them to do something worthwhile to improve the standard of their living. Perhaps pay some long overdue bills or outstanding debts? Committee member, Errol Jacotine and his wife, Violet, were present when these payments were made and reduced to tears at the sight and circumstances of some of those beneficiaries.

Frequently, we get donations with the request that it be given to someone who is really needy or to someone with special needs. This puts us in a quandary because, as far as we are concerned, ALL our beneficiaries are those with special needs of one kind or another. They have all been picked for assistance because of their special needs. Their applications were examined in minute detail by our Management Committee and only the most needy were selected. So, it would be better if donations are made to our general fund from which we assist ALL our beneficiaries by way of a common 'pension' and also by helping them in other ways; for instance, out of the emergency fund or paying for their cataract replacement and other medical emergencies or even home repairs. Donations to individuals would assist one person only while we strive to assist ALL of our beneficiaries.

May God reward you all.

## THE PRESIDENT'S REPORT

Both these gentlemen had made very significant contributions to our club and will be sadly missed. May they rest in Peace.

As usual, our regular lunches and the annual dance were very well supported and I thank the patrons of these functions and the caterers who contribute in no small measure by providing not only very tasty and sumptuous meals but at very reasonable cost.

A special Thank You to Mazhar and Melanie Rauf, who have been caterers at the majority of our lunches, for their benevolence. They have been more than generous with their pricing and donations.

To those very great supporters of our Club the De Silva family, Lorraine, Victor, Shanaka and Krishan, a very heartfelt Thank You. These wonderful people have now donated in excess of \$70,000 and have agreed to a further function which is to be held at their grandiose reception centre, The Grand, on the 3<sup>rd</sup> of July. ## HOW YOUR MONEY 15 SPENT

The following were assisted out of the Emergency Fund up to the 4<sup>th</sup> of April 2011:

Rs. 3000 - Mrs. C Hopman. Aged 66 and lives with her son who does temporary work. No income and needs medication - pressure in her eyes.

Rs. 1000 – Mrs. R Mortier aged 57. Has a heart condition and cannot work. Says that her children do not care for her.

Rs. 3000 - Mr C Kelaart aged 63 years. Has no income and is blind. Wife is also sickly and they were desperate.

Rs.2000 – Mr H Tranchell. Both husband and wife are ill. He cannot work and they have no income.

Rs. 3000 - Mrs O Williams. Had a fall recently and could hardly walk. Needed money for medication.

Rs. 2000 - Mr L de Zilva. Has a rash on his body and is entering hospital for treatment.

Rs. 2000 – Mrs M Rajapakse aged 69 years. Has no income. Has a 40 year old son who is mentally challenged and she is going through a difficult time.

Rs. 1000 - Mrs B Gomez. Has a rash on her head and needed money for medication.

Rs. 1000 - Mr E T Lappen. Is just out of hospital and needed money for medication.

Rs. 2000 – Mrs V Schrader. Needs to take some tests after being diagnosed with diabetes.

The welfare beneficiaries had good news when they drew their normal benefits at the end of April· Each of them was paid an additional mid-year bonus of Rs·3000 to the accompaniment of much jubilation· Fund raising Committee member, Leonie Martenstyn, was present at these payments

We had occasion to replace two of our Welfare Beneficiaries with two from our waiting list. The two new Beneficiaries are:


1.Mrs. R Rajaratnam nee de Zouza (Burgher) aged 80 years. Widow. Homeless, but lives with daughter-in-law for a few days and then with friends. Has bad eyes and is in debt. 2.Mrs. M LaBrooy aged 55 years. Widow. Has a disabled son aged 25 years. She suffers from ischaemic heart disease and epilepsy and cannot work. Lives in house house owned by brother, rent free.

## HOW YOUR MONEY IS SPENT (contd)

In this edition's editorial I informed members that fifty-one of the more needy welfare beneficiaries had been given a special one-off payment of Rs.14,000 each. I give below details of how some beneficiaries intended spending this largesse and regret that a lack of space does not permit details about other's intentions:



On the left is Mr G Muller who is 74 years old and walks around with two bags on each shoulder as he has no place to live. All his worldly belongings are in those bags. He sleeps in the corridor of a public building. He will use this money for daily food, medication and other expenses



railway line. She ran behind and grabbed him just as a train passed by. An open door hit them and she and her son were flung to the ground. The son died and her leg was injured to the point where she cannot straighten it. She also lost a son who drowned in a well that he was digging. She will use her money to clear debt, buy medication and day to day expenses





On the left is Miss D. Avery. Suffers from a pink pigmentation all over her body and also blood poisoning. Needs constant medication and nourishment. Her joy at receiving this extra payment is very apparent!



The lady on the right is Mrs B.

Fryer. She is 65 years old and will use her money to improve the floor of her home and plaster the walls. She has a son who was hit on his head with an iron bar when he was 16 years old. However, after prolonged medication, he is now better and doing a 'small' job.





On the left is Mr R. Johnson who is 64 years old.

He uses crutches to walk as he was electrocuted and fell from a tree when he broke his spine. Is always in poor health. His daughter was also burnt badly after an accident with a bottle lamp. Money will be used for day to day expenses involving medication etc. Altogether a very unfortunate family.

On the right is Mr R.Hansay who is 29 years old. He has no legs

below the knees as they were sliced off when he was run over by a train. Still, he is a tailor by trade and supports a wife and three children with help from this Club. His two thongs are tied to the stumps of his feet with string!

## TRAVELS ABROAD THAT WE ARE AWARE OF


Errol and Violet Jacotine spent a few days in Colombo and Singapore recently and plan another junket in December. Lucky couple!

CHARITY IS BENEVOLENCE, OR AN ACT BASED UPON A BELIEF IN THE GOODNESS AND WORTH OF OTHER PEOPLE.

### 1. History of the Term

O The word "charity" comes from the Latin "caritas," meaning "costliness, esteem, affection." Early Christians used "caritas" as a Latin translation of the Greek term "agape," which described a universal non-sexual love for other people. Current usage of "charity" typically implies an action in assistance of someone needing help.

### Meanings

O Charity is commonly used to describe an organization that facilitates charity benefiting people in need. It also often refers to the act of giving money, time or resources to others without expecting reciprocation.

## **Religious Significance**

 In Christianity, charity is one of three Theological Virtues, an inborn altruistic impulse to unconditionally love and selflessly assist all people.

### **Benefits**

A recipient of charity not only receives assistance with a financial or physical hardship, but also a confirmation of his or her worth and the assurance that everyone deserves kindness. Likewise, charity can help the self-esteem of the giver, who may feel more connected to the community or take comfort in his or her ability to help the less fortunate.

The Eighty Club Melbourne, Inc. fulfils every definition of a charity. Almost every cent of its earnings and donations goes to help the less fortunate members of our community in Sri Lanka. The Club has no such thing as 'service charges'. Those in want are never sent away empty handed but are always assisted through our emergency fund. In addition, 200 individuals/families are given a monthly 'pension' which the Club refers to as a welfare benefit. They are also helped with the cost of cataract operations and other medical problems.

Members of the Club derive only the extreme satisfaction of belonging to a Club that does so much for the poor. They get no financial benefit by being members since they pay full price for entry to fund raising lunches and other events. Indeed, they are invariably out of pocket because they donate prizes for the raffles and contribute in other ways to the success of these events. We are probably the ONLY Club that , in our newsletter, give the names of the persons we help since the recipients of our largesse in Sri Lanka are anxious that their names be published in case relatives and old friends recognized some of them and wished to help further.
